



## Excerpts from Council Members' Registers of Interests

Under Section 70(a1) of the *Local Government Act 1999*, the council must publish on the website, in accordance with the regulations, the following details about a council member as recorded in the Register of Interests:

- the member's income sources (within the meaning of Schedule 3 to the *Local Government Act*) or employer;
- the name of any political party, any body or association formed for political purposes or any trade or professional organization (within the meaning of Schedule 3) of which the member is a member;
- any gifts received by the member that are required to be included in the information entered in the Register in relation to the member.

The table below contains the required information which was current as at 30 June 2016.
